One possibility which councillors might wish to consider would be to focus on the event as a Christmas Entertainment rather than an evening of Christmas carols.

Transport and Works Act 1992 The Network Rail (Felixstowe Branch Line Improvements – Level Crossings Closure) Order

The Parish Council of Trimley St Martin discussed the proposals at their meeting on 4 April and concluded that they could not support them. Their objections are set out below.

- 1. This proposal relates to the construction of a bridge at Gun Lane, the closure of level crossings and changes to the public rights of way and does not touch on the Trimley loop work, but many of the problems associated with it relate to the proposed location of the loop within the context of the wider permissions secured in 2008. Were the loop to be located further along the line towards Ipswich, the aim of increasing capacity on the Branch Line could be achieved with a much diminished impact on local residents and leisure users. The Parish Council does not accept Network Rail's contention that the benefits of the loop would be lost were it to be positioned closer to Ipswich.
- 2. The proposed position of the single passing place would have a significant impact on local residents who would be severely affected by the noise and air pollution associated with trains idling in the loop for lengthy periods. The Parish Council has been advised by Network Rail that the new loop has been designed to be 'dynamic' and thus trains should pass through the loop rather than idling there. However, as they point out, if the timetable is disrupted there may be some dwelling in the loop and the Parish Council's concern is that

this may be a regular occurrence. The impact on local people will grow in significance as more and more new houses are built in the vicinity.

- 3. The plan to close six level crossings is considered to represent a significant loss of amenity for local residents. The crossings are used by walkers and equestrians and the Bridleway Bridge is not considered to be an appropriate alternative. The St Martins crossing, Trimley Footpath and Grimston Lane Crossing were considered to be the least used of the six, but the remaining three are of considerable importance to the community.
- 4. The Gun Lane Bridge is considered unsuited to its purpose. The equestrian community regard it as being unsafe for horses and riders as the proposal fails to address the needs of any but the most Noteile of horses. In consequence of this the plans will deprive most equestrian users of a crossing with the result that riders will be forced to make use of the main road with all its attendant dangers. It is appreciated that Network Rail have consulted with the British Horse Society and adapted their plans to reflect that organisation's advice, but the local view is that, even with the adaptations proposed, the bridge would remain unsuitable.
- 5. The proposed bridge is in a quiet rural area on the border of an area of outstanding natural beauty. The addition of a large, unsightly metal structure would greatly detract from the beauty of the area. In the fullness of time tree planting would screen it from view from some angles, but screening can never address the significant visual impact on users of the bridge which cannot be mitigated by the passage of time. The Parish Council noted comments made by Ben Gummer MP in the Ipswich Star on 10 March in relation to the importance of good design; comments which they felt reflected their own views in relation to the design of the bridge. Mr Gummer wrote, "If you accept poor design and an ugly environment you also implicitly condemn the people who must live and work in those places to a life less happy and contented than they would otherwise enjoy. It is the simple reason why I am so passionate about good design in our town making sure that whatever is built, however small, should be as good as possible."
- 6. Were it to prove impossible to reposition the loop to a more suitable location a bridge of a more traditional and attractive design, or an underpass, would be a more suitable means of achieving a crossing thereby reducing visual impact to a minimum and facilitating crossing by pedestrians, equestrians and farm traffic.

Trimley St Martin Parish Council Network Rail Proposals - Questionnaire

Network Rail already have permission to lay additional track so that more trains can run on the Felixstowe Branch line. Network Rail say that the extra trains will make it more dangerous for level crossing users in the Trimley area and so they have put forward plans to close six level crossings and replace them with a bridleway bridge. The crossings they want to close are at Thorpe Common, Grimston Lane, Trimley, St Martin's, Gun Lane and Keepers Lane. The plan includes the diversion of existing footpaths so that people who previously used the six crossings would be diverted to use the bridleway bridge instead. Network Rail propose that the bridleway bridge should be located between the current locations of the Gun Lane and St Martins crossings. The highways crossings at Thorpe Lane and Trimley Station are not planned for closure.

Network Rail need permission from the Secretary of State for Transport to make these changes. Because there has been opposition to their plans the Secretary of State has now decided that **there will be a public enquiry**. We have not yet been told the date set for the enquiry, but we must lodge our statement of case by 28 June. To help gauge the views of people in Trimley St Martin, the Parish Council is asking residents to complete this short survey as soon as possible.

UK Power Networks

The following extract is taken from a UKPN press release issued in April:

The ambitious £30m plan by UK Power Networks, which invests more than £500m in its electricity networks each year to ensure the lights stay on in the East of England, South East and London, has already seen seven kilometres of trenches dug, one kilometre of cable laid, and new high voltage equipment installed between Ipswich and Felixstowe.

While this work is continuing, the second phase gets underway next week, which includes:

- directional drilling under the rivers Orwell and Stour a distance of 1.1km and 1.7km respectively
- effectively linking the peninsulas together under the riverbeds
- digging trenches to lay new cables in Shotley,
- laying 12km of 33,000-volt cables between Felixstowe, Shotley and Dovercourt.

Project manager Chris Sugars said: "It's quite rare for electricity companies to undertake such a challenging project to drill beneath two major rivers, so we are bringing in expert teams to help us carry out this work.


"Much of the first phase is on farm land and we have liaised with multiple organisations to safeguard natural habitats and archeological artefacts, such as the foundations of an Iron Age round house which were uncovered last year and the recent discoveries of medieval wells.

The Clerk spoke to Paula Booth, AONB Officer at SCDC about the absence of any planning permission application and she explained that the cabling work would probably fall under permitted development rights. These rights enable certain types of work to be conducted without needing to apply for planning permission. They derive from a general planning permission granted not by the local authority but by Parliament.

The Clerk has also been in touch with Chris Sugars, the project manager at UK Power Networks, and he has offered to come along to speak to the Parish Council about the work that they are doing if that would be of assistance. He is offering a daytime slot or a Wednesday evening. I understand that the reason that we have not been the focus of consultation previously is because in Trimley St Martin the work is going on over private land. James of Bidwells informed me that the track which UK Power Networks had laid over the estate farmland would be retained, at Bidwells request, as it allowed farm vehicles to use the track when they would otherwise have had to use the public highway. I have also heard from Julie Steel Streetworks and Stakholders Manager at McNicholas who has provided a design drawing that shows their cable route through the Trimley area. She writes:

As you can see on the attached drawing[seenext page), our works are going through fields/farm land (for which relevant land owner consents have been obtained). We will then be carrying out a HDD (horizontal directional drill) on the edge of the Trimley Marshes under the River Orwell over to Shotley. The majority of the drill equipment will be coming through the Felixstowe Noteks. This section of works is expected to commence around the end of June & will have a presence on site for the remainder of the year. We would be more than happy to arrange for yourself & anyone else from the Parish Council to come for a visit to site.

Councillors will wish to decide if they would like a meeting convened in order that Chris Sugar may attend to provide information about the work of UK Power Networks and/or whether representatives would like to visit the site to discuss progress.



Telefonica – Proposed Base Station installation

Telefonica is seeking a suitable site in Trimley St Martin for a radio base station to provide 2G, 3G and 4G coverage in the area. The previously considered proposal to install the equipment at Trimley Sports & Social Club has fallen through and, after consideration of a number of alternative sites, they are proposing to apply for planning permission for the mast to be erected adjacent to the bus stop on the south side of Howlett Way.


The installation will amount to a 15m high monopole with shrouded antennas and two 300mm dish antennas along with an equipment cabinet.

Telefonica have confirmed that they have been in touch with Suffolk County Council and that the appropriate rights/agreements are in place for installations at all of their sites prior to any works taking place.

They say that they are consulting in line with the Code of Best Practice, but are happy to extend into the next Parish given the proximity and are happy to extend the deadline for comment to 7th June. A consultation letter to Trimley St Mary Parish Council was planned to be issued on 30 May 2017.

The proposed installation would connect to the existing underground REC power supply. The proposed meter box is similar to those installed at thousands of roadside locations across the UK and would present no risk to users of the nearby bus stop.
