Public Session

County Councillor John Goodwin gave his report which included:

- Gun Lane Bridge: There were no major developments to report, responses had been made to the Network Rail consultation exercise and as part of the process Trinity College had proposed a bridge of a different design more in keeping with the location.
- There was no progress to report on Highways issues where the difficulties of taking any improvements forward were currently very considerable.
- There was possibility that some asylum seekers would be accommodated in Felixstowe and Woodbridge as these towns had good transport links with Ipswich, but this would be subject to the availability of suitable private sector accommodation and this was being researched by G4S who are working on behalf of the Home Office. There would be a meeting with Felixstowe Town Council in February and County Councillor Goodwin had asked that representatives of Trimley St Martin and Trimley St Mary Parish Councils be invited to attend.

Parish Council Meeting

Councillor Garrett proposed that Councillor Parker be elected as Vice-chairman; Councillor Rodwell seconded the proposal, following a unanimous vote Councillor Parker was duly elected.
